Dear Riders, Dear Managers,

We are pleased to announce the start of the enrolments to FIM Women's Circuit Racing World Championship - WorldWCR 2024.

Please find below Permanent Teams enrolment procedures for:

WorldWCR will be competing in the following **6** rounds of the MOTUL FIM Superbike World Championship 2024 calendar.

1. Emilia Romagna Round, Misano World Circuit "Marco Simoncelli"	June 14-16
2. UK Round, Donington Park Circuit	July 12-14
3. Portuguese Round, Autodromo Internacional do Algarve	August 9-11
4. Hungarian Round, Balaton Park Circuit	August 23-25
5. Italian Round, Cremona Circuit	September 20-22
6. Spanish Round, Circuito de Jerez-Angel Nieto	October 11-13

Riders **minimum*** age is **18** years old.

The entry fee for permanent riders is set at €25,000 (will be invoiced in 3 tranches (April, July, September) and to be paid during the season by the deadline established in the agreement).

Permanent Entry Fee includes:

- > the use of Yamaha YZF R7 MY 2023
- ➤ a GYTR Racing Kit
- Pirelli tyres (on a lease basis)
- > Fuel
- Racing service (incl. Clinica Mobile assistance, permanent and one event credentials, motorcycle logistics, technical support and access to the Paddock Village.) *

^{*}The Rider must be **minimum 18** years old on **31 December** in the year of the Championship.

^{*} motorcycle extra parts/damages repairs are not included and must be covered by the team/rider



Permanent Riders'/Teams' enrolment procedures are as follows:

A. PRE-APPLICATION

- i. Please fill in attached "Pre-Application Form" and send it in <u>electronic format</u> using the function "SUBMIT BY EMAIL".
 - All the fields of the form with * are compulsory.

All the information of the pre-app should be accurate as it will be used to draw team/riders' agreement 2024.

[You will need an Adobe Acrobat Reader DC to complete correctly the pre-app. https://www.adobe.com/acrobat/pdf-reader.html];

- The form should be submitted only by email (no handwritten forms, images or scanned copies will be accepted and therefore processed).
- ii. Being the very first year of the FIM Women's Circuit Racing World Championship, <u>there</u> is no specific deadline for submitting the pre-applications

<u>DWO</u> reserves the rights to close the enrolments the moment the maximum number of permanent riders has been reached.

iii. Please be aware that submitting the Pre-Application Form does not guarantee your team or riders enrolment to FIM Women's Circuit Racing World Championship 2024, as long as the steps indicated hereinafter are finalized.

B. ACCEPTANCE OF PRE-APPLICATION

- i. Having received your permanent pre-application, Dorna WSBK Organization Srl ("DWO") will inform you via email if your application has been accepted in order to follow up with the enrolment process or if your application is on a standby until further notice.
 - <u>If no communication is provided this shall mean that your application has not been</u> successful.
 - ii. Please be aware that the <u>acceptance of Pre-Application Form does not guarantee</u> your team or riders enrolment to the FIM Women's Circuit Racing World Championship WorldWCR 2024, as long as the steps indicated hereinafter are finalized.



C. DEPOSIT

Once your application has been accepted, each team/rider will be requested to provide guarantees to its commitment to participate in the championship for which it has applied. To this purpose the team shall have to:

- i. Perform the payment of a deposit: €10.000, 00** per rider (within 7 days from the day of acceptance confirmation)
 - ** The deposit shall be retained by DWO as a guarantee for compliance by the team/rider with any payment obligations arising from its participation in the relevant 2024 Championship. The corresponding amount shall be deducted from the last payments due by the team/rider to DWO in connection to its participation in the relevant 2024 Championship.
- ii. Provide written acceptance to the terms and conditions applying to the deposit. Said terms and conditions shall be provided by DWO and shall clearly state that:
 - a. <u>NO REFUND of the deposit will be possible,</u> in case of a team or riders withdrawal.
 - b. No compensation of the deposit shall be allowed with payments other than the payments due by the team to DWO, as indicated by the latter, at its exclusive discretion:
- iii. Only after the deposit has been received and the corresponding terms and conditions accepted in writing, the commitment of the team to participate to the FIM Women's Circuit Racing World Championship 2024 shall be intended confirmed & the team/riders will be added to the Provisional Permanent Entry list 2024.

D. PARTICIPATION CONTRACT

Permanent Team/Riders Agreements will be sent thereafter to the teams/riders for signature by all parties involved and shall have to be entered in according to timing provided by DWO (in any case no later than the first test/race of the season) in order to fully complete the enrolment of the team/riders.
